At the time of application, new residential construction or new service connections applicants must submit an affidavit from either the Town of Portsmouth Building Inspector or a licensed plumber stating that all plumbing meets code requirements and a back-flow prevention valve is installed.

**Transfers or Sales of Property:** All homes on the PIWD water distribution system are required to install a back-flow prevention valve at the homeowner's expense by August 1, 2020.

An affidavit from either the Town of Portsmouth Building Inspector or a licensed plumber is attached.
